SF195 was passed by the Judiciary and re-referred to HHS committee. The HHS committee will not hear policy bills until they finish their budget bill. Sen. Limmer's office expects the bill to pass as a free-standing bill rather than being rolled into an omnibus bill.

HF447 (Kelly) was heard in HHS Reform Committee. Candace Ballstadt provided testimony on behalf of Elder Justice Network and Faith in Action. Carmen Castaneda testified about the bill's value to Adult Protective Services agencies. Next stop for the House File: Committee on Public Safety.

### 2:30 Related Legislation

State Budget – CCSA for Vulnerable Children and Adults – Report from Deb Siebenaler(DHS):
 Governor initially proposed \$22 million over two years in cuts to CCSA, which are block grants

for county social services services. His revised budget has \$5 million in cuts. DHS is committed to prioritizing these funds for vulnerable children and adults. Still, there is recognition that if preventive services are eliminated, additional people may be at risk of vulnerable situations.

- Licensing Fees for Background Studies: hold for next month's agenda.
- HF424 (Scott) civil remedies in vulnerable adult cases. Iris Freeman, Kevin Hansen, Greg
  Marita and Deb Siebenaler met with Rep. Scott regarding the bill which stems from a
  constituent's family experience. The group explained potential issues with bill, including the
  problem of changing definitions. There is no Senate companion bill. Bill has not been heard or
  scheduled to be heard. The bill may provide incentive to discuss additional civil remedies for
  vulnerable adult cases.
- HF827 (Hamilton), a bill concerning nursing home rate equalization, was amended yesterday to limit the reporting requirements for nursing home and boarding care home staff to Federal Law. The bill was held over for inclusion on Health and Human Services Finance package. Beardsley explained that this was brought up a couple years ago and there did not appear to be support from the VAJP. Had no intention to bring the concept forward this year, but there has been a change in power at the Legislature and a week and a half ago Rep. Abeler came to providers and asked for ways to streamline regulations. Providers gave a list, including eliminating reporting suspected maltreatment to the Common Entry Point, per state law.

## 2:50 Sexual Abuse in Later Life: Policies for Prevention – Deb Holtz, Ombudsman for Long-Term Care

• Minnesota Department of Health Website has information from Feb. 25 presentation. One panelist was Christine Davidson who focused on the community. Deb Holtz presented on policies regarding sexual abuse in later life. Promising practices and policies for prevention are few. What's needed: data collection, review mandated training, examine physical spaces, privacy issues, how to interview people. Holtz used Albert Lea cases as examples. As people age, may have been a victim of sexual abuse at younger age and then something triggers it. Discussed need for better safe places. Issues raised: how to balance rights of nursing home residents to safety and self-expression, and bringing people back to the community.
